

A Bounce Above Party - Rental Agreement

This is to certify that the costumer/client agrees to the following conditions by A Bounce Above while the equipment is under the customer/client's control:

- 1.) The customer understands that there are possibilities of injuries and accidents while the equipment is in use. The customer assumes the risk of renting the equipment.
- 2.) The customer shall be solely in charge of crowd control and shall also be responsible for the damage and impairment of the inflatables equipment. The customer shall be liable in case of criminal acts like theft. The customer shall also let everybody attending the event know the dos and don'ts while using the equipment. The customer shall read and share the rules and regulations to all the guests that will make use of the inflatables equipment. The client shall also have an onlooker on standby to make sure that everybody in the event is safe from danger and injury.
- 3.) The customer agrees that all of the users of the equipment shall remove their shoes and take away all of the sharp and hazardous objects to keep everything and everyone safe including the inflatables equipment. A small number of people and those who are age under 14 years old are the only ones allowed to play in the inflatables.
- 4.) The customer shall be legally responsible for the repairing cost incurred if ever the equipment is damaged but in repairable condition. However, if the equipment is damaged but irreparable (or lost/stolen), the customer shall be liable for the full replacement value of the whole equipment.
- 5.) The customer approves to the condition that he/she shall pay a fee of \$50.00 for cleanup, in any case that the equipment is excessively dirty during the time of return and pickup.

- 6.) The customer agrees that he/she shall TURN OFF AUTOMATIC SPRINKLERS (only if applicable for the user) and NOT ALLOWING THE PARTICIPANTS TO MAKE USE OF SILLY SPRINKLERS (or any similar products) for these things are harmful for the equipment. Failure to do so will make the customer pay for the cost of damage incurred for repairing the inflatables equipment.
- 7.) A Bounce Above, its employees, staff, contractors, owner/s, and/or heirs shall not be responsible for unforeseen circumstances such as weather conditions and power failures. In case of unpredicted events, the customer shall notify A Bounce Above at least by 7 o'clock in the morning of the event. If the conditions are not favorable and the customer cancels the delivery, there will be no refunds if the condition changes.
- 8.) The customer shall provide a safe level area (with no steps) for delivery and for pickup. Unless stated by A Bounce Above, the customer shall not move the whole equipment from where it is primarily placed.
- 9.) Participants shall wear socks when entering the inflatables. Do not bring toys, pets, foods and drinks inside the inflatables. **ADULT SUPERVISION IS STRICTLY REQUIRED.**
